**IMPORTANT NOTICE:** Effective April 5, 2010, all liquids, aerosols, and gels in excess of 3.4 ounces (100 ml) will be prohibited from being brought into the E. Barrett Prettyman Courthouse and William B. Bryant Annex. Jurors who display their jury summons are exempt.

Please follow the instructions below as it may or may not be necessary for you to appear in court each day:

- Step 1:** Carefully read all instructions beginning with the back page of this summons.
- Step 2:** Complete the entire questionnaire and return it within 10 days of receipt.
- Step 3:** Before reporting, you must begin calling the automated phone system at 202-354-3518 on Thursday, June 15, 2017 after 5:00 p.m. to obtain reporting instructions for Friday, June 16, 2017 and continue calling every evening until Thursday, June 29, 2017.

You will need to punch in your 9 digit participant number located above your name and address on this summons. You may either call the automated phone system or use the on-line juror system on the U.S. District Court's website (<https://jury.dcd.uscourts.gov/AppearWeb/Default.htm>) to obtain reporting instructions. The day and time to report for jury duty will be given when you call the phone system or check on-line after 5:00 p.m. on any given day.

- Step 4:** If you are scheduled to report at 8:00 a.m., always use the William Bryant Courthouse entrance on 3rd Street NW (Open 24 hours). Bring this summons with you on any day that you are instructed to report. If you are instructed that "there is no jury selection" when calling the automated phone system or checking the on-line juror system, go to work or continue your normally scheduled activities and follow Step 5. No credit or jury pay is given to jurors who appear to court when no jury service is scheduled or were never physically required to appear in court because no trials were scheduled during the jury service term.
- Step 5:** All jurors must call the automated phone system or check the on-line juror system every evening after 5:00 p.m. for the next business day's reporting instructions to avoid any penalties. Do this every evening until the last scheduled day on this summons.

**WARNING:**

Under Federal Law, any person summoned for jury service who fails to appear as directed may be ordered by the district court to appear forthwith and show cause for failure to comply with the summons. Any person who fails to show good cause for noncompliance with a summons may be fined not more than \$1,000, imprisoned not more than three days, ordered to perform community service, or any combination thereof. You may be subject to a fine, imprisoned or both 28U.S.C§ 1866(g). For those employers who retaliate against employees who serve on jury duty or who are scheduled to attend in connection with such service may be fined \$5,000 28U.S.C§ 1875(b)(3).

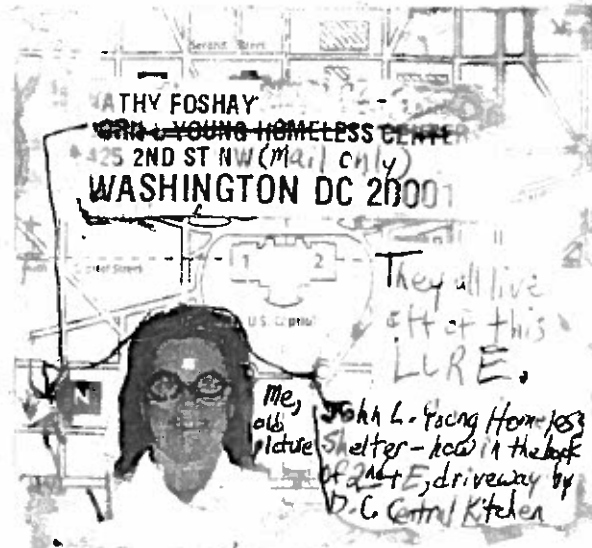
